How do I register??

6. JLA (Jessica Lunsford Act) Badge Expiration Date (Needed for postseason assignments)
7. Upload/update profile picture. (Optional)
8. Select your association(s): primary, secondary, tertiary. You only need to select one if you do not have a secondary or tertiary association. If you have not contacted a local association please visit our directory of approved associations www.becomeanofficial.org/directory.
9. Select which association will be your PRIMARY association.
10. Payment- Review your registration information and payment.
